# Research Grants – One-Year Grants for Doctoral Candidates • DAAD

#### Overview

#### Objective

This programme offers you the opportunity to carry out research primarily as part of doctoral projects in Germany.

#### Who can apply?

You can apply if you have above-average qualifications and

- are already taking a doctoral degree or
- are not yet taking a doctoral degree and you have already completed a Master's degree or Diplom, or in exceptional cases a Bachelor's
  degree, at the latest by the time the funding period begins.

Postdocs may not apply.

#### What can be funded?

The programme provides funding for a research project or continuing academic training at a state or state-recognised institution of higher education in Germany or a non-university research institute, which is being carried out in agreement with a supervisor in Germany.

# **Duration of the funding**

- Funding is provided for between 7 and a maximum of 12 months. Please indicate in your application how long you wish to receive
  funding. The funding period will then be determined during the selection process by a selection committee. The committee takes into
  account your study plan.
- The grant is non-renewable.

# Value

- Depending on academic level, monthly payments of 861 euros if you do not yet have a Master's degree, 1,200 euros for doctoral candidates
- Payments towards health, accident and personal liability insurance cover

If a language course scholarship is granted and the working language at the host institute is German, participation is compulsory. Due to the pandemic, German courses may take place online.
- Allowance for a personally chosen German language course during the funding period
- Reimbursement of the fee for a TestDaF or DSH test, which you can take either in your home country after you have received your Scholarship Award Letter or in Germany during your funding period.

#### Selection

An independent selection committee consisting of specialist scientists reviews applications.

The selection criteria are:

#### 1. Qualification

- Academic achievements (grade point average, development of grades)
- Academic progress
- Knowledge of the language of instruction or working language
- If applicable, scholarly achievements after graduation, (e.g. publications, lectures, conference papers)

#### 2. Quality of research project

- Quality of research proposal and preparation (originality, topicality and relevance of the project, choice of host institution and first contacts)
- Feasibility and consistency of study plan and schedule (analysis and evaluation stages)
- Incorporation of project within the overall doctorate (in terms of content and time), if relevant

#### 3. Potential of applicant

- Career prospects: significance of the research project and stay in Germany for further academic, professional and personal development
- Motivation: academic and personal reasons for wanting to visit Germany, German language skills (if different from working language)
- · Non-study-related activities: non-study-related knowledge and skills, civic engagement

The selection committee also gives due consideration to equal opportunities; you can provide relevant information in the application form.

# Research Grants - Doctoral Programmes in Germany • DAAD

# Overview

#### Objective

The aim of this grant programme is to support doctoral projects in Germany.

# Who can apply?

Excellently-qualified young academics and scientists who have completed a Master's degree or Diplom, or in exceptional cases a Bachelor's degree at the latest by the time they begin their grant-supported research.

#### What can be funded?

Doctoral programmes at a state or state-recognised institution of higher education or a non-university research institute in Germany:

- individual projects under the supervision of a university teacher or academic adviser
- participation in a structured doctoral study programme

# **Duration of the funding**

- a maximum of four years; the length of the grant is decided by a selection committee and depends on the project in question and the
  applicant's work schedule.
- Grants are initially awarded for a maximum of one year. Extensions depend on whether the selection committee considers the previous award period to have been successfully completed.
- For doctoral projects in Germany that require several years of research, research phases outside Germany can be supported if these are
  critical for the successful completion of the doctoral degree. Planned stays must be specified in the application in the work and time
  schedule and should not exceed a quarter of the anticipated total funding period.

- Depending on academic level, monthly payments of: euros 861.- for graduates, euros 1,200.- for doctoral candidates

- academic achievements

In addition, in order to ensure equal opportunities, the selection committee may take into account special life circumstances, about which you can provide information in the application form.

- Letter of admission to a study programme; this can be subsequently submitted before the grant-supported research begins if it is not available at the time of application.
- Proof of existing contacts to the coordinator of the doctoral programme in the form of copies of correspondence

#### Also for all applicants:

- University degree certificate indicating final grade(s): the certificate must be subsequently submitted before the grant-supported
  research begins if it is not available at the time of application.
- Other documents which support your application (example: certificates of employment, proof of practical training/internships and voluntary commitment etc.)

# Research Grants - Bi-nationally Supervised Doctoral Degrees / Cotutelle • DAAD

## Overview

#### Objective

This programme offers you the opportunity to do a bi-national doctoral degree at your home university and at a university in Germany. There are two possible options:

#### Option a) Doctorate with bi-national supervision:

Your doctoral project is supervised by a university teacher both at your home university and at the host institute in Germany (so-called "sandwich model"). Your project must be agreed with both supervisors according to the following procedure:

- You start your doctoral degree in your home country.
- This is followed by research trips to Germany.
- You complete your doctorate in your home country and are also supervised by the German academic adviser.
- Your home university awards the doctoral degree.

#### Option b) Doctorate following the "Cotutelle" procedure:

Funding is provided for doctoral projects that are carried out at the home university and at a university in Germany according to the so-called Cotutelle model. This is based on an individual cooperation agreement which is concluded individually for your doctoral project by the participating universities. After you have successfully completed your doctorate, the German university and your home university award the doctoral degree jointly.

#### Who can apply?

Depending on the nature of your project, you can apply for:

- a) bi-national supervision based on the "sandwich model". You can apply if you have earned a Master's degree or Diplom (or in exceptional cases a Bachelor's degree) at the latest at the start of the funding period.
- b) "Cotutelle model". You can apply if you have been admitted to a doctoral programme at the latest at the start of the funding period.

#### What can be funded?

- In option a), a doctorate with bi-national supervision based on the "sandwich model", research stays at a state or state-recognised
  institution of higher education or a non-university research institute in Germany (as part of a doctoral programme in the home country)
  are funded.
- In option b) a doctorate based on the "Cotutelle model", research stays at a state or state-recognised institution of higher education in Germany are funded. These allow doctoral students to complete a doctoral thesis which is supervised and carried out bi-nationally on the basis of an individually concluded cooperation agreement.

#### Duration of the funding

- Funding is provided for between 7 and a maximum of 24 months.
- Option a) Bi-national supervision following the "sandwich model": Grants are initially awarded for up to 12 months. Extensions depend
  on whether the selection committee considers the previous award period to have been successfully completed.
- Option b) Doctorate following the "Cotutelle" procedure: Grants are initially awarded for up to 18 months; there is the possibility for an
  extension of the scholarship for up to 6 months.

- When you apply for the grant, you should outline in your study plan and time schedule how you intend to divide your time between Germany and your home university.
- If you plan to visit other countries (e.g. to collect material), please specify these plans in your application. Such visits can only be
  funded if they take place in connection with your visit to Germany. Another requirement is that they do not exceed one quarter of your
  expected total funding period.
- The length of the funding period is determined by a selection committee and depends on your project and study plan.

#### Value

- Monthly payments for doctoral candidates during the stay in Germany: 1,200 euros. Please note that no scholarship payments are
  made during stays at your home university.
- Payments towards health, accident and personal liability insurance cover
- Travel allowances I https://static.daad.de/media/daad\_de/pdfs\_nicht\_barrierefrei/im-ausland-studieren-forschen-lehren/daad\_reisekostenzuschuesse\_stipendiaten.pdfl for up to three outward and return journeys unless these expenses are covered by the home country or another source.
- A research allowance
- Travel and accommodation expenses according to the German Federal Travel Expenses Law for your supervising university teachers for one trip of up to 10 days
  - to Germany to monitor progress
  - to your home university to take part in final examinations.
  - Please indicate the trips in the work and time schedule (see "Application documents") when applying.

Under certain circumstances, grant holders completing an uninterrupted stay of over 6 months in Germany may receive the following additional benefits:

- monthly rent subsidy

# Study Scholarships - Postgraduate Studies in the Field of Architecture • DAAD

#### Overview

#### **Objective**

This scholarship programme offers you the opportunity to continue your education in Germany with a postgraduate or continuing course of study in the field of architecture. The scholarships also promote the exchange of experience and networking amongst colleagues.

# Who can apply?

You can apply if you have gained a first university degree in the areas of Architecture, Interior Design, Monument Conservation, Urban Planning/Urban Development, Landscape Architecture, Landscape Planning at the latest by the time they commence their scholarship-supported study programme.

#### What can be funded?

In this study programme, you can complete

- a Master's degree/postgraduate degree leading to a final qualification or
- a complementary course that does not lead to a final qualification (not an undergraduate course)

at a state or state-recognised German university of your choice.

If you are enrolled in a Master or postgraduate degree programme which includes a study period abroad, funding for this period abroad is usually only possible under the following conditions:

The study visit is essential for achievement of the scholarship objective, the visit does not take place in the home country, and it is no longer than a quarter of the scholarship period. Longer periods cannot be funded, even partially.

This programme only funds projects in the area of Design/Projects.

When selecting the desired degree programmes, please take care that they provide a minimum number of CP (credit points according to the European Credit Transfer System/ECTS) for the area of Design/Projects.

This means for degree programmes with

- 120 CP at least 45 CP
- 90 CP at least 34 CP
- 60 CP at least 23 CP.

DAAD scholarships cannot be used for participation in degree programmes which do not meet this requirement. Information on the quantitative distribution of CP can be found in the module overview of the degree programmes on the website of the respective university.

Other DAAD scholarship programmes are available for applicants from the field of History of Architecture or applicants with a scientific project.

# **Duration of the funding**

Master's degree programme:

- Between 10 and 24 months depending on the length of your chosen study programme or project
- Start: usually from 1st October of the following year after the application, or earlier if a German language course is taken prior to the study programme

The scholarships are awarded for the duration of the standard period of study for the chosen study programme (up to a maximum of 24 months). In the case of two-year programmes, your academic achievements in the first year of study are assessed. To receive further funding for the second year of study, your academic achievements thus far must indicate that you will successfully complete your programme within a reasonable period of time.

# **Objective**

This scholarship programme offers you the opportunity to continue your education in Germany with a postgraduate or continuing course of study in the field of music. The scholarships also promote the exchange of experience and networking amongst colleagues.

# Who can apply?

You can apply if you have gained a first university degree in the field of Music at the latest by the time you commence your scholarship-supported study programme; if this is not possible, you should have at least exhausted all the training options available for your instrument in your country of origin.

#### What can be funded?

In this study programme, you can complete

#### Who can apply?


