2023 Mitsubishi Corporation Research Funding Solicitation Guidelines

1. Outline and Mission

Mitsubishi Corporation commitment to contribute to build prosperous, sustainable societies in the places where we operate worldwide is deeply embedded in our corporate culture based on our corporate philosophy, the Three Corporate Principles. Mitsubishi Corporation established an office to foresee social and environmental affairs in 1973 in recognition that, as good corporate citizens, companies should actively pursue initiatives to contribute to society, and that the expense of those activities should be borne as part of the social cost of doing business before reaping any profits. Since then, Mitsubishi Corporation has promoted a number of self-driven corporate philanthropy projects with the aim of improving our global society. As an example, Mitsubishi is focusing on how to conduct a battery waste management for EV and e-bike in order to create a sustainable business process and eco-friendly environment. On the contrary, It is interesting to note that there are no waste management market emerging in Indonesia. In the absence of such complete eco-system, the development of battery industry may not be sustainable.

2. Research Fields to be supported

The Mitsubishi Corporation Research Funding provides financial support for outstanding original research projects contributing to the development in science and technology. The major field of research supported is Battery Waste Management.

3. Eligibility

Applicants must be researchers at ITB who are personally engaged in graduate-level research projects in faculties/school or research centers.

4. Applications

4.1. Deadline

Proposal must be prepared in English and submitted to LPPM ITB no later than February 23, 2023 via MyPPM (https://myppm.itb.ac.id/).

4.2. Budget and Duration

The budget for the grant will be one (1) million to a maximum of two (2) million Japanese yen per project, which will be decided by the steering committee of ITB. The term of the project will be one (1) year beginning in November 2023. The funds will be remitted by the Mitsubishi Cooperation in October 2023 irrespective of the duration of research of the individual projects accepted.

4.3. Items of Expenditure to which Grant Funds may be used

- a. Instruments, devices and/or apparatus
- b. Laboratory supplies and/or experimental reagents
- c. Travel expenses
- d. Miscellaneous (printing, communications, etc.)

5. Screening Process

- a. ITB will announce a call for proposals for 2023 Mitsubishi Corporation Research Funding on February, 13th 2023.
- b. All submitted applications will be evaluated by steering committee based upon originality, academic and/or social significance, and clarity of the proposal and relevance of the topic.
- c. Steering committee will report the result of evaluation to ITB by March 6th, 2023.

6. Targeted Research Output

All research funded by 2023 Mitsubishi Corporation must publish their research result at least one paper in a reputable journal with category of Q1 Journals based on SJR (Scimago Journal and Rank). Acknowledgement should be included in the following way:

"This research was supported by Mitsubishi Corporation"
